Dear Madam, Sir,

Reproductions (or originals) of press content (press articles, pictures,...) are maybe reused in your company/institution/organisation. As you know (and as stated in the copyright mentions on press publishers' websites and in paper newspapers, magazines and free press titles), this content is protected by copyright. You're legally entitled only to consult clippings or to use them in the conditions expressly defined by the legal licenses (e.g. photocopies for internal use in return for a fee paid to Reprobel).

All other uses (so-called "secondary" uses) <u>strictly</u> depend on the prior consent of the right holder of the content. Such authorisation may be subject to a set of conditions (among others the remuneration for the intended use).

**Copiepresse** s.c. is a rights management company, created by the publishers of <u>Belgian French- and</u> <u>German-speaking daily newspapers</u>, in order to ensure the promotion and the protection of their copyright, as well as to control the exploitation by others of their copyright protected works. It has also concluded reciprocal agreements with two rights management societies, CFC and Luxorr, which allow it to manage the reproduction rights of articles from the French and Luxembourg press within Belgium.

**License2Publish** cv is the Flemish counterpart of Copiepresse and represents the publishers of B<u>elgian</u> <u>Dutch-speaking daily newspapers</u>.

**Repropress** sc. represents most of the publishers of <u>Belgian magazines and free press titles</u>.

Taking into consideration our mandates, we would like to ask you to declare **before June the 1<sup>st</sup> 2023** what your <u>reuses of press content</u> were in 2022.

For your convenience, you'll find a declaration form that you can:

- either fill out online (<u>http://declarations.copiepresse.be</u>) thanks to the following username and password
  - username : «id»
  - password : «token» (Be careful : do not mix up number "0" et letter "O")
- or print in PDF format (<u>www.copiepresse.be</u> or <u>www.license2publish.be</u>, heading "Répertoire et tarifs"/"Repertorium en Tarieven") and send it back to us by e-mail (<u>info@copiepresse.be</u>) duly filled out.

In case of non-observance of the deadline, we keep the right to make use of every legal means, to stop infringements to our members' rights as we would do for any counterfeiter.

The statement is on your honor and may be subject to audit. Any false or incomplete declaration will be considered as an infringement to copyright law and will lead to proceedings.

The declaration applies **to any press content Copiepresse, License2Publish and Repropress represent** and that is <u>stored</u> on digital media <u>and/or distributed</u> electronically <u>within your</u> <u>company/institution/organisation and/or externally (e-mail, intranet, extranet, internet), etc.</u>

Please fill out the form **even if** you do not reuse any press content: tick the box "**NOT TO REPRODUCE**, **NOT TO SPREAD** press content..."

Once we receive the filled in form, we will, <u>if need be</u>, issue an invoice\* in order to cover secondary uses of our content made by your company/institution/organisation. Should the invoice refer to a purchase order, please indicate it the "comments" section of the declaration.
