Any **false or incomplete declaration** will be considered as an infringement to copyright law and will lead to the **necessary proceedings**. The objective of this declaration is to regularise potential illegal copies of our copyrighted works as fast as possible.

This includes among others: the implementation of an electronic press review, the electronic reproduction or the scanning of press content in order to constitute a database or to spread them on the Internet, an Intranet or an Extranet, their use in documents distributed outside the company, the reproduction in a newsletter, etc.
